There was no Contingency Plan developed or documented by the Licensee at the time of the inspection. A written plan should have been in place by 7/5/22.

Facilities, general.

The outdoor pen housing 9 pigs had several plastic calf hutches/sheds that provide shade and shelter for the animals. One of the hutches/shelters was in disrepair and had partially collapsed, and there was an approximately 12" x 8" section of plastic missing from the top of the entryway to the hutch. The edges of the plastic along the missing portion were sharp and/or pointed and could cause an injury to the animals when they enter/exit the hutch/shed.

Per this Section, outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury. The Licensee immediately corrected this item at the time of the inspection by removing the damaged calf shed from the swine pen.

Watering.

Each of the two outdoor swine pens contained a large metal water trough/water receptacle. Both of these water troughs had a greenish brown residue adhered to the sides and bottom of the receptacle.

Per this Section, all water receptacles shall be kept clean and sanitary. Animals should have access to potable water. Dirty water receptacles can affect the quality and palatability of the water, and the animals may decrease their intake of water. The Licensee immediately corrected this item at the time of the inspection by emptying, cleaning, and refilling both water receptacles with fresh water.

This inspection and exit briefing were conducted with Licensee.
