ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*** Several dogs were matted and in need of grooming. Once the fur becomes matted, it pulls and separates from the skin causing potential skin irritations and exposes the animal to the elements. These dogs need to be groomed on a routine basis to prevent matted fur for their comfort and well being. These dogs included a Poodle #7E10084657, Shitzu # 7E10084649 and a Pekingese #7E10084668.

*** There were a few expired drugs in the fridge and cabinet stored with drugs that are currently in date and use. These included Pyrantel lot # 0650046 expired 09/2016 and Fish Flex lot # 12310 expired 08/2015. Expired drugs need to be discarded in a timely manner so they are not accidentally used in the kennel. In addition a few medications have been put into smaller bottles but their label information was not transferred. When medications are put into containers different from their original one, pertinent information such as the drug, dosage and expiration should also be labeled. This needs to be addressed for the health of the dogs.

INDOOR HOUSING FACILITIES.

*** Several sections of the wood frame for the enclosures have been scratched or chewed to the point they are no longer impervious to moisture. Any surfaces that come in contact with the dogs must be impervious to moisture, therefore this wood frame needs to be cleaned and re sealed to facilitate cleaning of the kennel.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

*** The area underneath the solid flood whelping boxes needs to be cleaned. There is an accumulation of shavings and debris that needs to be removed to keep the area clean. In addition, the area around the cabinet that contains medications and supplies in the puppy room needs to be cleaned. General areas around the kennel need to be kept
