HOUSING FACILITIES, GENERAL.

*** One of the center wire mesh panels between two enclosures is in disrepair with broken wires that are protruding into the enclosures. These enclosures must be maintained in good repair for the safety of the dogs.

3.1(c)(2)

HOUSING FACILITIES, GENERAL.

*** The carpets in a few whelping boxes, have fresh shavings, but the carpet underneath is soaked with urine resulting in a strong ammonia odor in the whelping room. These carpets must be replaced when soiled to keep the puppies dry and clean.

3.3(e)(1)(iii)

SHELTERED HOUSING FACILITIES.

*** Several enclosures in the kennel using wood surfaces are no longer impervious to moisture. These areas include whelping boxes or interior boxes in the main kennel, or wooden frames and doors for the outdoor enclosures. These sections of wood need to be addressed to make the surfaces in contact with the animals impervious to moisture for cleaning and sanitation purposes.

*** In addition, several sections of the wire mesh flooring is no longer coated wire, and the exposed wire is showing signs of rust. Rust does not allow the area to be sanitized properly and these areas of rusted wire need to be addressed.

3.11(b)(2)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

*** The main kennel is not being sanitized on a routine basis of every two weeks as evidenced by the build up of hair and feces when mats were pulled back or items in the boxes were moved. In the whelping room, the floors underneath the carpets were dirty and not being cleaned. The schedule of cleaning for the facility needs to be addressed and enclosures cleaned and sanitized at least once every two weeks to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards.

3.11(c)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

*** Housekeeping needs to be addressed in multiple areas of the kennel. The whelping room has an accumulation of dead flies on the window ledges which should be removed. Several enclosures were empty but still had food in feeders which can be an attractant to pests. Several enclosures were empty but still dirty and need to be cleaned to reduce odors in the kennel. There was an accumulation of weeds underneath the outdoor section of enclosures that need to be controlled to reduce living areas for pests. Premises where housing facilities are located must be kept clean and in good repair to protect the animals and to facilitate good husbandry practices.
