Attending veterinarian and adequate veterinary care (dealers and exhibitors).

A female Cavachon puppy id # 157 was keeping her right eye closed. The right eye appeared smaller than the left eye and the puppy was hesitant to open the eye when handled pulling away from the inspector, indicating a potential pain response. The condition of this dog's eye had not been observed by the facility and hence its condition was not communicated to the veterinarian. The facility must have a method in place to ensure daily observations are conducted on animal health and that when health issues are noted, the issue is communicated in a timely manner to the veterinarian. 3.9(b)

Feeding

Currently the feeders are not in a location that is easily accessible to the dogs in the enclosure. The feeders are hung higher up over the sides of the enclosure above the dogs head when standing, which causes the dogs to have to stand on their back legs to reach the feeder. These feeders need to be lowered to be at a level that allows the dogs to easily reach the feeders and eat in a normal posture for their wellbeing.

3.10(a) Direct

Watering

One of the automatic drinker nipples for two dogs was not working and there was no water access in the enclosure. When water was provided in a bowl, the two dogs identified as "Licorice" and "Fredrick" drank continuously for over two minutes and Fredrick drank continuously for up to four minutes. Water must be continuously available to the dogs for their health and wellbeing. The facility must have a method in place to ensure all the automatic drinkers are functioning properly allowing water to continuously flow or another method of having continuous access to water is in place. Correct by: Sept 20, 2023
