ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*** There were expired medications found in the drug cabinet. Two bottles of ALBON de-wormer with an expiration date of 6/2013 and 8/2015, injectable Tylan expired 3/2015, Injectable Lyncomycin expired April 2015, and a jar of Bird Biotic with an expiration date of 9/2015. In addition there were no directions or a label on the Bird Biotic as to indicate dosages and application of its use in the dogs. Use of expired medications is not acceptable and can cause harm to the dogs, and medications must be listed on the Program of Veterinary Care with dosage information and a description of when it should be used.

HOUSING FACILITIES, GENERAL.

*****A container of clean bedding was observed uncovered, without a lid in the kennel area. There were two mice observed sleeping in the center of the container. Pests can contaminate bedding material and can cause health issues with the dogs. Bedding material must be stored in a container with a tight fitting lid and must be stored in a manner which will protect it from contamination.

*****Two unopened bags of dog food are being stored in the kennel area and are in direct contact with the concrete floor. This can lead to contamination of the food sources and could possibly have a negative health impact on the dogs. Food must be stored off of the floor in order to prevent contamination and allow cleaning of the floor underneath.
