3.6(a)(2)(iii) CRITICAL

PRIMARY ENCLOSURES.

*** The current outside runs are gravel floor with wire mesh along the sides. The wire mesh is not buried and the dogs are able to dig underneath into adjacent enclosures. A few of the dogs have the ability to jump out of the enclosures and then jump into another dogs enclosure. On May 20, 2018 a Yorkie # 4023 was able to dig underneath into another enclosure and was subsequently killed by a Labrador retriever. At the time of the inspection, several Boston terrier puppies had dug underneath the wire and were in multiple adjacent enclosures housing adult breeding males and females. This is dangerous for these puppies as they could be injured by the adult dogs. In addition, a jack russel terrier had jumped out of its enclosure, killed a chicken and then jumped into the boston terrier enclosure and deposited parts of the chicken in with the puppies. There was a large amount of chicken feathers throughout the out door run.

These outdoor enclosures must be constructed to contain the dogs securely and keep other animals from entering their enclosures. This needs to be addressed for the safety of the dogs.

FEEDING.

*** For several of the smaller breeds of dogs, the feeders are several feet off the ground making it necessary for the dogs to continually jump up to access food or potentially jump into the feeder. It was requested by the inspector that a thin Yorkie with the feeder high up, was given a bowl of food on the ground, and when given easy access food, the dog began to eat continually for an extended period of time. These food receptacles must be readily accessible for the various sizes of dogs for their comfort and well being.

*** Housekeeping needs to be addressed at the facility. There were discarded items around the outdoor runs including, plastic bags, empty cleaning bottles, syringe caps etc. Since these dogs have the ability to dig under or jump out of the enclosures, these discarded items could be a potential ingestion hazard. There were also weeds growing up into the outdoor runs bringing up the black mesh fabric meant to block grass growth. This fabric is in the dogs outdoor enclosure with easy access to the dogs and can be a hazard if the dogs chew and ingest the fabric. Additionally, the outdoor runs are not having fecal waste removed daily which is a requirement of 3.11 (a). Housekeeping needs to be addressed for the health of the dogs and to keep the area clean and in good repair.
