Time and method of identification.

A total of 5 puppies under 16 weeks of age and 3 dogs over 16 weeks of age did not have official identification as required by the Animal Welfare Act. In one enclosure, 5 puppies under 16 weeks of age were present without their dam. They were identified by a cage card but had not received official identification after being weaned and removed from their mother. Another 2 dogs, older than 16 weeks, were present in the same cage also without official identification (only documented on a cage card). In another kennel, a newly acquired puppy under 16 weeks of age did not have official identification, only identified by name. Official identification for all dogs under 16 weeks of age and separated from their dam and all dogs over 16 weeks of age is important to trace the movement of animals and account for those present on the property. Correct by June 2, 2023 by ensuring all puppies under 16 weeks of age separated from their dam and all dogs over 16 weeks of age have a form of official identification such as an official tag, tattoo approved by the administrator, or microchip.

The facility does not have a comprehensive written contingency plan to provide for the humane handling, treatment, transportation, housing, or care of their animals in the event of an emergency or disaster. If an emergency or natural
