ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

*** 7 animals were found in need of veterinary care during the inspection. This included:

1. One black male guinea pig was housed in pen #29. This guinea pig had a right eye that was being held partially closed and had brown crusty debris on the upper and lower lid accumulating in the corner of the eye closest to the nose.
2. One white and brown male guinea pig was present in pen #30. This guinea pig had an open wound under the chin on the left side of the chest. The hair around the wound was matted down with a pink - bloody discharge, and the wound appeared to be fresh.
3. One brown and white baby pup guinea pig was present in pen #37. The pup stayed huddled in one spot and did not move, even after the rest of the guinea pigs being housed in the enclosure ran around and past it during the observation. The pup had a dehydrated/sunken appearance and was in thin condition.
4. One black and brown male guinea pig was in pen #38. There was a quarter sized wound on its left side. There was a copious amount of grey brown pus like discharge present in the center of the wound, and the hair around it was dried and crusty.
5. One brown female was housed in pen #33. This guinea pig had a left eye that was being held partially closed and had brown crusty debris on the hair surrounding the entire eye. In addition, the guinea pig was exhibiting respiratory distress and was making abnormal breathing sounds.
6. One black female guinea pig with a white and brown face was housed in pen #13. This guinea pig had a left eye that was being held partially closed and had brown crusty debris on the hair surrounding the entire eye.
7. One brown female guinea pig was housed in pen #23. This guinea pig had a right eye that was being held partially closed and had brown crusty debris on the hair surrounding the entire eye.

Inspection Report

Appropriate diagnosis and treatment of these animals is necessary to ensure humane care. Correct by having these animals examined by a licensed veterinarian for diagnosis and the development of an appropriate treatment plan for animal each condition. Documentation of this examination, the treatment plan, implementation of the treatments, and recommendations for prevention / control of disease spread to the remaining animals shall be maintained by the licensee for examination by APHIS Officials upon request.
