PRIMARY ENCLOSURES.

The following enclosures need repair.

- 1) The top 8th enclosure in row one housing 10 guinea pigs has rusty and detached wire on the left side.
- 2) The top 8th enclosure in row two housing 8 guinea pigs has rusty and detached wire on the right side.
- 3) The top 5th enclosure in row four housing 10 guinea pigs has chewed metal with holes on the left partition.

Enclosures must be structurally sound and maintained in good repair to protect the guinea pigs from injury and to contain the animals securely. The above enclosures must be repaired or replaced to prevent injury to the animals and to prevent escape. Correct by June 1, 2017.

WATERING.

There were accumulations of brown debris around and inside the drain pipe for the automatic water receptacles. These accumulations around and inside the drain pipe expose the guinea pigs to potential disease infections with bacterial, fungi, and parasites. Water receptacles including water valves and drain pipes must be cleaned and sanitized whenever dirty and at least once every two weeks. Inadequate cleaning of the water valves and drain pipes can result in contamination of the the guinea pigs in the same enclosure. Licensee must establish and maintain a program to keep the water valves and drain pipes sanitized when dirty, and must be sanitized at least once every two weeks. Correct by May 18, 2017.

SANITATION.

There is a heavy buildup of brown scale, feces, and debris on the floor of the guinea pig enclosures. Licensee stated that the enclosures were last cleaned over a week ago. The buildup of brown scale, feces, and debris exposes the guinea pigs to potential infections with bacteria, fungi, and parasites. Correct by ensuring that all primary enclosures are cleaned and sanitized often enough to prevent a buildup of brown scale, feces, and debris. Additionally, ensure that the primary enclosures are sanitized at least least once every two weeks. Correct by May
