ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The following guinea pigs were identified as needing veterinary care:

- 1) The 5th enclosure had a white adult guinea pig and tan on face with hair loss approximately 2 inches in diameter and two sores on its back.
- 2) The 8th enclosure had a white adult guinea pig and black on head with hair loss on the right side of the nose that was approximately 1 cm. The underlying skin was crusty and had numerous scabs.

These two animals were not on any treatment and had not been evaluated by the attending veterinarian. These conditions are not covered by the current program of veterinary care. Hair loss, sores, and scabs of this type can occur for a number of reasons including both infectious and traumatic. Failure to properly diagnose and treat animal conditions can result in worsening of the condition. These two guinea pigs must be examined by the attending veterinarian so that appropriate veterinary care can be provided. Additionally, the licensee must maintain records of veterinary recommendations and treatment provided by future evaluation by APHIS officials. Correct by March 15, 2018.

PRIMARY ENCLOSURES.

The following enclosures need repair.

- 1) Enclosure I housing 6 adult guinea pigs had chewed/detached metal on the right partition with bare wood exposed.
- 2) Enclosure 33 housing 9 adult guinea pigs had chewed/detached metal on the left partition with bare wood exposed.

Enclosures must be structurally sound and maintained in good repair to protect the guinea pigs from injury and to contain the animals securely. The above enclosures must be repaired or replaced to prevent injury to the animals. In addition, the bare wood must be sealed or covered with an impervious surface so that the enclosures can be

repeatedly cleaned and disinfected. Correct by March 26, 2018.

WATERING.

There were accumulations of brown debris around and inside the drain pipe for the automatic water receptacles. These accumulations around and inside the drain pipe expose the guinea pigs to potential disease infections with bacterial, fungi, and parasites. Water receptacles including water valves and drain pipes must be cleaned and sanitized whenever dirty and at least once every two weeks. Inadequate cleaning of the water valves and drain pipes can result in contamination of the the guinea pigs in the same enclosure. Licensee must establish and maintain a program to keep the water valves and drain pipes sanitized when dirty, and must be sanitized at least once every two weeks. Correct by March 14, 2018.
