There were no inventory records maintained of guinea pig births and deaths for review for the last three months. Records must be kept and maintained on guinea pig births, deaths, owned, held, euthanized, sold or otherwise disposed of by the breeder/dealer. Licensee must ensure that records of guinea pig births, deaths, number owned, held, and sold are maintained to keep track of animals, document changes in ownership, and to help assess the animal care program. Remains uncorrected.

3.25(a)
Facilities, general.

There were 2 adult guinea pigs loose on the floor and hiding with hay stacked on a pallet in the corner of the animal room. Housing facilities need to protect the guinea pigs from injury and contain the animals securely. Failure to do so can lead to injury or death from falls from guinea pig racks to the floor, escape from the animal room, or become trapped outside the enclosure. Correct by ensuring that enclosures are properly maintained to prevent escapes. Correct by February 10, 2022.

Housekeeping. There were accumulations of hay, bedding, dirt, and debris covering the floor of the guinea pig room. There were accumulations of dust, dirt, and debris on window sills, and shelves in the room. Ineffective cleaning and housing can lead to pest problems and can expose the animals to disease and health problems, Correct by ensuring shelves, window sills, and floor are kept clean, including: removing hay, bedding, dirt, and debris from floor and other surfaces; and maintaining a level of general cleanliness to support good animal husbandry and health. Remains uncorrected.
