The written program of veterinary care on file states that the attending veterinarian will visit the premises at least annually. The attending veterinarian has not visited the premises in over a year nor reviewed the written program of veterinary care on file. Each dealer must employ an attending veterinarian under formal arrangements which include a written program of veterinary care and regularly scheduled visits to the premises. Failure to have regularly scheduled visits by the attending veterinarian could result in animals not receiving adequate veterinary care. Correct by scheduling a visit by the attending veterinarian and updating any changes to the written program of veterinary care on file.

Records: Dealers and exhibitors.

A current record of guinea pigs on hand was not available for review. A total of 864 adult guinea pigs, 331 weanlings, and 281 newborns were counted today. There were no inventory records for the the number of adults, weanlings, and newborns for several months. Failure to maintain these records can make it difficult to assess the health of the caviary by identifying guinea pig additions and losses or decreases in the number of animals born or animals kept for replacement breeders. The facility must maintain complete records containing the required information which fully and correctly discloses the number of guinea pigs held, owned, and disposed of including births and deaths.
