Records: Dealers and exhibitors.

A current record of guinea pigs was not available for review during this inspection. A total of 337 adult guinea pigs, weanlings, and newborns were counted during this inspection. There were no inventory records kept and maintained since the previous inspection report. Failure to maintain these records makes it difficult to assess the health of the caviary by identifying animal losses by decreased number of guinea pigs born, raised, or died. The licensee must maintain records containing the required information for animals which disclose the number of guinea pigs held, owned, acquired or disposed of including births and deaths. Remains uncorrected.

3.25(c)

Facilities, general.

Storage. There is an open bag of guinea pig feed and an open bag of shavings on the floor of the animal room. Failure to store food and bedding supplies adequately can result in spoilage, deterioration or contamination from pests. Open bags of feed must be stored in containers with lids or covers to protect supplies from contamination. Open bags of shavings should not be stored directly on the floor to protect the the bedding from moisture or contaminated by pests. Correct by April 1, 2023.

Inspection Report

Feeding. The self-feeders on the sides of the guinea pig enclosures were covered with dust, dirt, and cobwebs. Failure to keep the self-feeders clean can result in deterioration or contamination of the feed. All food receptacles must be kept clean and feeders must be sanitized at least once every 2 weeks. Correct by March 30, 2023.

3.31(b)

Repeat

Sanitation.

There are accumulations of dust, dirt, and cobwebs covering the sides of the guinea pig enclosures, racks, walls, ceiling, window sills, and drainage pipes. There is hay, empty bags, shavings, and excreta on the floor of the animal room. Animal facilities must be kept clean to ensure good quality of the air for the animals and to prevent unnecessary disease risks. Correct by ensuring the premises are kept clean, including: removing accumulations of dust, dirt, cobwebs and debris from surfaces; routinely cleaning surfaces and the floor of the animal room; and maintaining a level of general cleanliness to support good animal husbandry and health. Remains uncorrected.
