There are several areas of the building where raw wood is exposed; front window sill, side door, ramp and door frame in between the two rooms. These areas are not impervious to moisture and can not be properly sanitized. The interior of all building surfaces shall be constructed and maintained so that they are substantially impervious to moisture and may be readily sanitized.

PRIMARY ENCLOSURES.

Enclosures C, D, 1 and 2 have exposed raw wood on the outside wall of the enclosure. Enclosures D, C, A and B have exposed raw wood on the water bowl holders located inside of the enclosures. Areas with raw wood are not impervious to moisture and can not be properly sanitized. All enclosures, including their racks, shelving and other accessories, shall be constructed of smooth material substantially impervious to liquids and moisture.

SANITATION.

There is spilled feed, shavings, empty food bags, clutter and excreta on the floor just as you enter the facility. This is also the location where food is stored. When objects were moved in this area, several black bugs were noticed to be crawling around. The pests identified on today's inspection are a direct result of improper cleaning and the availability of a food supply and locations for the unwanted pests to hide. The Licensee cleaned this area prior to the exit briefing. The Licensee must ensure that there are methods in place to keep the building and grounds clean, free of clutter and the accumulation of trash to prevent future pest issues and the contamination of food.
