The current method of euthanasia that's listed on the Program of Veterinary care is unacceptable under AVM euthanasia guidelines. The current method must be changed by the attending veterinarian and documented on the (PVC). The current method is to painful and unacceptable for chinchilla euthanasia. The licensee must make provision to change the current euthanasia protocol and work with her Attending Veterinarian on a proper method. Correct from this day forward

ACCESS AND INSPECTION OF RECORDS AND PROPERTY; SUBMISSION OF ITINERARIES.

On a routine inspection approximately 1000 chinchillas were noted in a room above the chinchillas that are used for (show animals, research and pet sales). The licensee stated she didn't think it was important to mention these show animals. She thought they didn't require inspections. These animals are in the same building and receive the same water, heat, air, food etc. that the animals get below. All of the show chinchillas must be inspected for possible veterinary care issues and subpart F of the CFR must be followed in regards to the housing of all chinchillas on site.

SANITATION.

The licensee has not been properly sanitizing the enclosure's as required. The enclosures must have a proper disinfectant and detergent used to prevent diseases and reduce odors on a regular basis. When enclosures are cleaned by hosing or flushing, adequate measures shall be taken to protect the animals confined in such enclosures from being directly sprayed with the stream of water or wetted involuntarily. The licensee must develop a plan for proper cleaning and sanitization for all of the chinchilla enclosures.
