ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Dog with USDA tag #261, White Female Poodle, was noticed to have a red/brown coloration around her mouth. In addition, she was noticed to be excessively licking her mouth. Upon further examination, this dog was noticed to have an excessive buildup of dental calculi on a majority of her teeth. Having dental issues can cause the dog pain and discomfort if left untreated. This dog was recently purchased on 10/20/2014 and is currently bred. Licensee must contact the veterinarian to set up and determine an appropriate timeframe for an examination. Documentation of the examination, diagnosis and treatment must be maintained and made available for inspection. Licensee should have this dog seen sooner if the dog is noticed to have trouble eating or is not maintaining normal body weight.

This dog was also noticed to have excessively long toenails on both feet. Long toenails can easily be broken and can affect the gait of the dog. Licensee must trim all long toenails. In addition, Licensee must establish a routine for grooming, to include toenail trimming, for the facility.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Dog with USDA tag #261, White Female Poodle, was noticed to have a red/brown coloration around her mouth. In addition, she was noticed to be excessively licking her mouth. Any abnormalities with the dogs should be noticed and documented while performing daily observations. If Licensee were to have noticed these abnormalities, he would have found that this dog had dental issues that need to be addressed. Daily observation is required to address all health issues within the facility. Licensee must have daily observation of all animals and have frequent communication with the attending veterinarian to ensure that all observed health issues are treated within a timely manner.
