Records: Dealers and exhibitors.

The Record of Dogs and Cats on Hand (APHIS form 7005) does not correctly disclose all of the dogs present at the facility. The facility currently has 25 adult dogs with only 21 adult dogs listed on the APHIS form 7005. Inaccurate or incomplete records do not allow for APHIS officials to perform a complete inspection of the facility and does not facilitate proper tracking of animals. Correct by ensuring that the records are fully and correctly disclosed for all dogs that are purchased or otherwise acquired, owned, held, or otherwise in his or her possession or under his or her control.

3.1(c)(2)

Housing facilities, general.

Three dog houses that are provided for 5 dogs, located in building 3, have excessive chew damage present. The chew damage is located around the entrance and protruding rim around each dog house. In the whelping area of building 2, there is chew damage present on the surfaces on the front walls of the kennel around the top rim. The damage was present on 5 kennel front walls. Chew damage can create sharp points that can cause injury to the animals and can not be properly sanitized. Correct by ensuring that all surfaces including houses, dens, and other furniture type objects within the facility that can not be readily cleaned and sanitized, are maintained or replaced.
