Having ear issues can be painful and irritating to the dog. This cause the dog to scratch, bite or rub the ears and may result in wounds/sores on the ears. Licensee must have methods to prevent, control, diagnose and treat all ear issues. These two dogs must be seen by a licensed veterinarian. Documentation of the examination, diagnoses and treatment must maintained by the licensee and made available for inspection by APHIS officials.
