### 3.11(a)

#### **CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.**

The adult primary enclosures consisted of elevated coated wire kennels with no exterior access and several tiled floor-level kennels with exterior access to concrete runs.

There was an excessive amount of excreta, and food waste underneath each of the elevated kennels covering approximately 30% of the floor surface.

On the interior tile surfaces and the exterior outdoor surfaces of the floor-level kennels there was an excessive accumulation of urine and feces covering approximately 10% of the floor surface.

It is important to remove excreta and food waste from the primary enclosures daily and from under primary enclosures as often as necessary to prevent soiling of the dogs contained within the enclosures and to prevent disease hazards, insects, pests, and odors.

### 3.11(b)

#### **CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.**

In addition to excessive amounts of excreta and food waste underneath the elevated kennels and within the tiled floor-level kennels there was an accumulation of yellowish to reddish brown fluid within the gutters going to the sanitary sewer drains which contributed to the overall poor odor of the facility.

Accumulations of dirt, debris, excreta, and food waste contribute to odors and other disease hazards for the animals.

In addition to cleaning and removing excessive amounts of food and excreta, the primary enclosures must be sanitized at least once every two (2) weeks.
