#### 3.1(e)

##### Housing facilities, general.

Food is not being stored in an appropriate manner. In the outdoor building housing the dog food, a stack of 10 bags of food was placed directly on the floor. Another stack of 10 bags of dog food was placed directly against the wall. On the surfaces adjacent to the bags of dog food there was evidence of rodent droppings. Food bags placed directly on the floor or against walls could become contaminated by pests such as rodents leading to possible illness to the animals. Correct by ensuring supplies of food and bedding are stored in a manner that protects the supplies from spoilage, contamination, and vermin infestation. The supplies must be stored off the floor and away from the walls, to allow cleaning underneath and around the supplies. All food must be stored in a manner that prevents contamination and deterioration of its nutritive value.

#### 3.6(a)(2)(ii)

##### Primary enclosures.

Enclosures are not protecting animals from injury:

- Exposed electrical cords are accessible to the animals in three enclosures each housing approximately 1 adult dog. Most of the enclosures housing animals also contain exposed electrical outlets accessible to the animals.
- Fly strips are accessible to the animals in four enclosures each housing approximately 1 adult dog.
- Several exposed nails accessible to the animals are seen on the ceiling of two outside runs each housing approximately one adult dog.

Sharp points, electrical cords, and fly strips that are accessible to the animals could cause injury and distress to the animals. Primary enclosures must be constructed and maintained so that they protect the dogs from injury. Correct by ensuring that the enclosures protect the animals from injury.

#### 3.13(a)(3)

##### Veterinary care for dogs.

The facility is not following the sampling schedule in the written Program of Veterinary Care (PVC). The PVC states to perform fecal sampling of 10 percent of adult dogs each year. The facility does not perform fecal testing on adult dogs.
