Housing facilities, general.

Extra supplies of dog food are currently stored on the floor and against the wall in the "picture room" and "quarantine room". Cleaning cannot be properly done under and around the supplies not allowing for adequate protection against contamination or vermin infestation. All supplies of food must be stored off the floor and away from wall to prevent contamination or infestation and to facilitate effective cleaning measures.

3.2(b)

Indoor housing facilities.

Upon entering the air conditioned rooms A and B used to house puppies, a strong ammonia odor was detected. The odor was strongest in room B but was easily detected in both rooms by the inspector even while wearing a N95 mask that decreases odor perception. The odor started to dissipate once the doors to the rooms were opened. Ammonia inhalation can be detrimental to animal health, especially the respiratory systems of dogs housed indoors. The licensee must keep the housing facilities sufficiently ventilated for the health and well-being of the dogs by minimizing odors, drafts, ammonia levels, and moisture condensation.
