Records: Dealers and exhibitors.

Of the 28 puppies at the facility, 15 of them were missing from the APHIS form 7005 Record of Acquisition and Dogs on Hand. The facility maintains its own paper intake forms and then transfers that information onto the APHIS form 7005 but reports they got behind. It is important to maintain an updated Record of Acquisition and Dogs on Hand for ease of inspection, tracking movements of animals, and for recovery in instances of loss or theft. Correct by ensuring the APHIS form 7005 is regularly maintained with up-to-date information of the puppies at the facility. Correct by: August 17, 2023.

3.1(c)(3)

Housing facilities, general.

There is an excessive accumulation of hair, dirt, and debris on the sides of two enclosures and on the bungee cords holding the self-feeders onto the enclosures. On one set of top and bottom- style enclosure there is a buildup of hair and brown organic material stuck around the woven wire sides of the enclosure. There is one puppy in each enclosure. On another similar style enclosure, the bungee cords used to attach the self-feeders onto the enclosures have an excessive accumulation of hair wrapped around the spring and cord. There is also some accumulation of brown organic debris stuck to the wiring on the top of the bottom enclosure and along the bottom and side of the top enclosure. Accumulations of hair, excreta, and other organic debris can draw pests, be a source of bad odors, and can harbor bacteria and other pathogens. Correct by ensuring all hard surfaces in which the dogs come into contact be cleaned and sanitized as often as necessary (a minimum of every 2 weeks) to prevent accumulation of debris and excreta. Correct by: August 17, 2023.

3.9(b)

Feeding

There were approximately 5 stainless steel self-feeders that contained moldy puppy food. The pieces of dry puppy food were fuzzy, white-grey, and in one instance, caked onto the bottom of the feeder. The enclosures these feeders were attached to did not currently house any puppies. Having moldy food in the feeders is problematic in case a puppy was to be housed in the enclosure and subsequently ingest the food. Additionally, moldy food could increase the potential for attracting pests and causing unpleasant odors in the kennel. It is unclear when the feeders were last cleaned and sanitized. Food receptacles must be kept clean and sanitized at least once every 2 weeks. Correct by implementing a cleaning plan which ensures the food receptacles are routinely cleaned and monitored so that there is no molding, deterioration, or caking of the food. Correct by: August 15, 2023. Corrected at the time of inspection.

Inspection Report

3.10(a)

Watering

Water was not continuously available to 8 puppies. Upon arriving at the facility, one Dachshund puppy and one Shih Tzu puppy were in a small, fenced-in enclosure in the grass and did not have a bowl of water. Inside the facility there was a large kennel with 6 poodle mix puppies who also did not have access to water. The facility representative stated the puppies were out of their normal enclosures for exercise. When asked by the inspector, the facility representative gave both groups of puppies a bowl of water. The puppies were observed to only play in the water, not drink. There is a risk of dehydration, stress, and overheating if water is not available, especially in the summer (environmental temperature is 85 degrees F today). Correct by ensuring potable water be continuously available to dogs, even while out of their normal enclosure for exercise. Correct by: August 11, 2023. This was corrected at the time of inspection.
