##### Facilities, indoor.

A strong odor of ammonia is present in the animal housing areas. The inspectors' eyes felt irritated throughout the inspection of the building. The licensee had cleaned the enclosures earlier in the day but there were still bags of soiled bedding in the isles of the animal housing area contributing to the smell. High levels of ammonia can cause discomfort to the animals and lead to further health issues.

Indoor housing facilities shall be adequately ventilated by natural or mechanical means to provide for the health and to prevent discomfort of the animals at all times. Such facilities shall be provided with fresh air either by means of windows, doors, vents, fans, or air-conditioning and shall be ventilated so as to minimize drafts, odors, and moisture condensation. The licensee must ensure that the ammonia is kept at a compliant level either by removal of ammonia causing waste and/or proper ventilation at all times in order to support the health of the animals. Correct by, 19-September-2025.

##### Sanitation.

Overall cleaning of the building is not currently facilitating the prescribed husbandry practices. There is a thick buildup of dust, hair, and debris on the top of and surrounding approximately 70% of all used and unused enclosures. In addition, over 60% of the enclosures not currently in use but mixed throughout the inhabited enclosures, have dirty shavings, fur, and spiderwebs making it difficult to see through the wire enclosures. Failure to maintain acceptable cleaning can contribute to disease hazards. The licensee must ensure that all premises (buildings and grounds) shall be kept clean in order to protect the animals from disease hazards and to facilitate the prescribed husbandry practices set forth in this subpart. Correct by, 22-September-2025.

This is a continuation of the report for the routine inspection conducted on 10-September-2025 and contains the remaining non-compliances found during the inspection. The exit briefing for the items included on this report was conducted on 10-September-2025.

This inspection was conducted with the licensee. The exit briefing for the non-critical non-compliances was conducted with the licensee on 10-September-2025.
