### 2.1(a)

#### Requirements and application

The applicant has been operating as a dealer after the license had expired on September 23, 2022. Conducting regulated activity without a valid license prevents APHIS officials from determining compliance with the Animal Welfare Act. Correct by ensuring that a valid license is obtained before operating as a dealer, exhibitor, or operator of an auction or sale.

### 3.1(c)(2)

#### Housing facilities, general.

There is excessive chew damage present on the surfaces on the front walls of the kennel around the top rim. The chew damage is also present around the tops of the dividers between the kennel stalls. The cage carpets used as whelping mats in the facility have chew damage resulting in frayed ends and loose pieces of material hanging from them. Chew damage on walls and dividers cannot be properly sanitized and can create sharp points that can cause injury to the animals. Chew damage on whelping mats with loose or frayed ends can lead to animal entanglement or accidental ingestion. Correct by ensuring that all surfaces including houses, dens, and other furniture type objects within the facility that cannot be readily cleaned and sanitized, are maintained or replaced when worn or soiled.

The facility has a exercise plan in place that has not been approved by the Attending Veterinarian. An Attending Veterinarian approved exercise plan ensures that all dogs are provided an appropriate opportunity for exercise and promotes animal welfare. Correct by providing an exercise plan that developed, documented, and followed. In addition to being approved by the Attending Veterinarian.

### 3.13(a)(3)

#### **Veterinary care for dogs.**

The Program of Veterinary care for the facility does not currently have testing schedule for heartworm or fecal testing. The facility has performed heartworm and fecal tests but do not have an Attending Veterinarian approved schedule to follow. Failure to have and follow a written and Attending Veterinarian approved schedule for sampling and treatment of parasites and other pests can lead to a delay in treatment for the animals in the facility. Correct by ensuring that sampling and treatment of parasites and other pests in accordance with a schedule approved by the Attending Veterinarian is followed.

This is a 1st Re-License Inspection for a Class "B" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by January 21, 2023 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
