ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

There were two dogs found with diarrhea in the pen. One is a Goldendoodle with ID # 468, the other a Newfoundland with tag # 216. The dogs in these two pens should be evaluated by the veterinarian to identify a cause and develop a treatment plan for the two dogs.

There was a female poodle with tag # 398 with her right eye very inflamed. The eye was filled with thick green mucous discharge. The eye needs to be evaluated by the veterinarian to determine a treatment plan for the care of the dog.

Contact the veterinarian by close of business August 26, 2015.

Provide care as indicated by the veterinarian.

Comply with all guidance from the veterinarian.

A young great Pyrenees owned by the son of the owner yet housed in the facility, was found to be slightly limping. Upon exam, the dog was very lame as well in the rear legs as well. An appointment was made with the veterinarian for 8/26/2015 for an evaluation. Comply with all guidance and provide care as indicated.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The licensee advised the inspectors that the conditions of the above listed animals had not been observed until the inspection.

It is imperative that all regulated animals are observed and assessed for their health and well-being daily by the licensee. Upon identification of an injury or illness the licensee must operate according to their PVC as indicated and/or contact a veterinarian in a timely manner in order for proper diagnosis and treatment to occur. Unidentified injuries or illnesses can cause undue discomfort or suffering for the animals and cause treatable mild conditions to

PRIMARY ENCLOSURES.

There were several areas of chewed surfaces in the outdoor housing area. There were chewed pieces that covered the posts in the supports for the pens. All surfaces in a primary enclosure must be in good repair to prevent injury to the animals.

Repair or replace the chewed broken sections by September 1, 2015.

PRIMARY ENCLOSURES.

One dog, a bernese mountain dog with tag # 364 was chained to a dog house. Tethering a dog can result in injury to a dog and is not permitted under the Animal Welfare Act.

The dog needs to be removed from the tether and re-housed safely in an enclosure.
