The licensee needs to have the attending veterinarian come to the facility at regularly scheduled visits.

TIME AND METHOD OF IDENTIFICATION.

Currently there is 1-yellow Lab, 3-Pekingese, and the female German Shepherd that do not have any identification on them by collar, tattoos or microchip ID.

Proper identification is required to be on all regulated animals in accordance with the regulations and standards for proper management and traceability of the animals in the facility.

The licensee must identify all regulated animals by an official tag of the type described in Sec. 2.51 affixed to the animal's neck by means of a collar or by a distinctive and legible tattoo marking acceptable to and approved by the Administrator or microchip.

females or any numbers of puppies born per female or records of sale or death of those animals. The 1-Lab, 3-Pekingese are not listed on the 7005 On Hand records, and both German Shepards' ID numbers are not located on the 7005. There have been some dogs that have been sold that have not had 7006 Disposition forms completed properly.

It is important to keep complete records of all acquisitions and dispositions' of regulated animals for proper management, care and traceability of the regulated animals.

The licensee must keep updated 7005 and 7006 forms of all animals that come and go from the facility, and keep track of any deaths or euthanasia's'. Complete puppy records of all puppies born by which female and when they were sold , donated, transferred or died at the facility.

HOUSING FACILITIES, GENERAL.

There are two outdoor runs with dog houses attached that house a male and female German Shepherd that has a buildup of dirt and grime on the side wall by the male and back walls of both dogs in the run area around the dog doors. The inside of the dog house portions have a thick buildup of dirt/grime and hair that is in the corners and along the front of the door entrance. This buildup is dark brown and 'gooey' in texture. Some of the dog doors in the kennel with the boxers have a dark brown/black dirt and grime buildup located on the surfaces of both sides of the door.

It is important that all surfaces that the regulated animals come in contact with are spot cleaned daily and able to be sanitized. A buildup of dirt and grime can harbor bacteria and disease that can affect the health and welfare of the animals.

The licensee must make sure all surfaces are cleaned properly to prevent a buildup of dirt and grime.
