RECORDS: DEALERS AND EXHIBITORS.

There are multiple puppy records with missing or incorrect ID numbers and missing the dates of sale. There are several Disposition forms 7006, that are missing the ID numbers and description. While there are records being made, there is an inconsistency with the ID numbers on the puppy records with those listed or not listed on the disposition records.

Puppy records and Disposition records require proper ID numbers and dates of sale for the management, care and traceability of the regulated animals.

The applicant must keep updated and accurate puppy records of all puppies born at the facility including their ID numbers and dates of sale and complete information of all animals an information of buyers/transporters as required on the 7006 disposition forms.

OUTDOOR HOUSING FACILITIES.

There are six Newfies that are housed in an outdoor area that has only 2 dog houses and not other additional shade or shelter. There is no other structure for the dogs to get under to provide shade or shelter from the weather. There are only 2 dog house shelters for 6 dogs, that are growing in size, there needs to be an additional shelter provided.

It is important for there to be one or more areas of shade/shelter for all of the dogs to fit under in an outdoor facility, besides the dog houses.

The licensee must provide an additional shade/shelter area that all of the dogs can fit under comfortably in order to be protected from the sun or inclement weather. There must be enough dog houses large enough to be able to
