#### TIME AND METHOD OF IDENTIFICATION.

There are 4 Golden Retrievers from December 2015 and 3 Pugs from May 2016 that have been added to the breeding stock that do not have any ID tags or identification. While the animals are listed in the Inventory (7005 Acquisitions form) they have not been given any ID#, tag or tattoo for proper identification according to AWA Regulations and standards.

Identification on the animals is necessary for proper management, identification and traceability,

All dogs in the facility must have proper identification with a tag as described in Sec. 2.51 affixed to the neck by a collar, or a tattoo or microchip approved by the Administrator.

#### CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

There are several feeders that have a buildup of brown grime inside the bottom of the feeder and around the rims. The feeders are being cleaned, but not sanitized in accordance with the regulation of at least once every 2 weeks or as often as necessary to prevent the buildup of dirt or debris.

The buildup of dirt and debris inside the feeders can be a source of possible health issues or disease.

Used primary enclosures and food and water receptacles for dogs and cats must be sanitized at least once every 2 weeks using one of the methods prescribed in paragraph (b)(3) of this section, and more often if necessary to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards
