There was expired pyrantel pamoate suspension dewormer (expired 07/2021) on hand.

Each dealer shall establish and maintain programs of adequate veterinary care that include the use of appropriate methods to prevent and control diseases.

Medications must be administered within date to provide the appropriate response and to protect the animals from contagious disease. The facility must ensure expired products are not used.

Housing facilities, general.

There was orange plastic snow fence coming up through the gravel in one of the four occupied outdoor portions of the sheltered kennels. There was evidence of chew marks.

Housing facilities for dogs must be designed and constructed so that they are structurally sound. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

The exposed plastic may pose a risk of injury to, entanglement of, and possible ingestion by the dogs. The licensee must ensure to keep the housing facilities in good repair.

3.11(b)(2)

Cleaning, sanitization, housekeeping, and pest control.

The licensee reported he last sanitized primary enclosures one month ago.

Used primary enclosures for dogs must be sanitized at least once every 2 weeks.

Primary enclosures need to be sanitized at a minimum of every 2 weeks to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards.

3.11(d)

Cleaning, sanitization, housekeeping, and pest control.

There were cobwebs and spiders present in the unoccupied kennels.

An effective program for the control of insects must be established and maintained so as to promote the health and well-being of the animals and reduce contamination by pests in animal areas.

The cobwebs can pose a fire risk and the spiders can cause potential injury to the animals. The licensee must ensure an effective pest control program is in place.

The program of veterinary care did not include recommendations to prevent unmatted hair coats, toe nail trims, clean and healthy eyes, ears, skin, and teeth.

The written program of veterinary care must address the requirements for adequate veterinary care for every dealer and must also include preventative care and treatment to ensure healthy and unmatted hair coats, properly trimmed nails, and clean and healthy eyes, ears, skin, and teeth.

Lack of regular preventative care can lead to medical issues, such as matted haircoats, overgrown toe nails, and poor eye, ear, skin, and dental health.

This is a 1st Re-License Inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by 12/20/2021 or the Applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Relicense Inspection.
