Attending veterinarian and adequate veterinary care (dealers and exhibitors).

A female hedgehog, cage card 51 F, has a wound on the skin adjacent to her left eye. There is a scab, approximately one centimeter in diameter, above the wound. The wound has inflammation around the edges with mild amounts of red material present. The licensee indicated she didn't see the lesion when the animal was observed two days ago. I asked the licensee how often the animals are observed, and she replied she observes them every two days. Daily observation of all animals is necessary to assess their health and well-being, so problems of animal health are conveyed to the veterinarian in a timely manner. Contact the veterinarian regarding this animal's condition. Ensure any prescribed treatments and/or instructions are completed.

The disposition records for every hedgehog sold in 2021 are incomplete. Over fifteen disposition records are missing the licensee's name and address as the seller of the animals. A cat litter box containing excessive amounts of cat feces is adjacent to the hedgehog enclosures. Without proper cleaning, the litter box can create poor air quality in and around the hedgehog enclosures. Ensure the hedgehog housing area is kept clean to provide for the health and well-being of the animals.

This is a 1st Re-License Inspection for a Class "A" license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by 4/30/2022 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
