SANITATION.

Two enclosures housing fennec fox have excessive feces and food waste on the resting platforms. The bushbaby enclosure has excessive buildup of feces and body fluids on the metal surfaces.

Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors.

Remove the feces from the primary enclosures to prevent contamination of the animals and reduce odor.

SANITATION.

On December 12, 2016 this licensee hosted an inspection at another facility. During that inspection, the licensee stated to me that she had lost a serval at her facility last summer to bee stings. After the serval was found deceased the licensee stated that she found a bee's nest inside the shelter for the serval.

A safe and effective program for the control of insects shall be established and maintained at the facility.

Facilities must be checked regularly for the presence of bees and bee nests/hives. A program to eliminate, or reduce bees must be established and followed to ensure that animals do not die or suffer from insect pests such as bees.

To be corrected by the time bees are present this year.
