ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The Program of Veterinary Care is not being followed. The program states all animals must be tested for Brucellosis prior to breeding, annual heartworm testing and preventative must be done and a monthly treatment for ticks and fleas must be used. The licensee is not following these veterinary recommendations. The licensee is removing dewclaws without written approval by the attending veterinarian.

Each dealer shall assure that the attending veterinarian has appropriate authority to ensure the provisions of adequate veterinary care and oversee all other aspects of animal care.

The program of veterinary care has to be followed as written by the attending veterinarian to ensure the health of the animals. Removal of dewclaws has to be completed by the attending veterinarian, or written consent from the attending veterinarian for the licensee to remove dewclaws has to be available.

The Program of Veterinary Care must be followed from this day forward.
Dewclaw removal cannot be performed by the licensee until the attending veterinarian approves the method in writing.

2.40(b)(2) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

There are at least 6 large breed, Basset Hounds and Golden Retrievers, that have overgrown toenails. Prolat/Lintox HD, a cow and pig insecticidal, was used on the small breed dogs for flea treatment. This product was not in the Program of Veterinary Care. Two Yorkies were nursing four puppies. The licensee stated that these four puppies died from the use of this medication because they forgot to wash it off.

Each dealer shall maintain a program of veterinary care as instructed by the veterinarian to include the use of appropriate methods to prevent, control, diagnose and treat disease and injuries.

Overgrown toenails must be clipped to prevent injury to the dog. Flea treatment must be approved by the attending

veterinarian to ensure that it is an appropriate product for use in dogs and does not cause death.

Toenail trims to be corrected by August 5, 2016.

All medications must be approved by the veterinarian from this day forward.

2.40(b)(3) DIRECT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The licensee stated that a Standard Poodle was lethargic and not acting right. The licensee dewormed the dog, but it died. The licensee did not consult the attending veterinarian concerning this dog. At least two of the Siberian Husky's have open wounds on the tips of their ears.

Daily observations must be made of all animals to assess their health and well-being. If these observations are conducted by the licensee a plan must be established for direct communication with the attending veterinarian on problems of animal health, behavior and well-being.

The attending veterinarian must be contacted at any time there are problems with the health and well-being of the animals. This is to ensure that health issues are addressed and treated prior to death or discomfort.

TIME AND METHOD OF IDENTIFICATION.

The small breed dogs that were present at time of licensing do not have any identification. The larger breed dogs that were acquired in January, 2016 are microchipped.

Class A breeders shall identify all live dogs on the premises.

All dogs must either be microchipped or have dog tags for identification.

RECORDS: DEALERS AND EXHIBITORS.

The records of disposition of puppies do not have the license number of the facility that the puppies were sold to.

Each breeder shall maintain records of sales that include the USDA license number of the person that the animals are sold to.

ACCESS AND INSPECTION OF RECORDS AND PROPERTY; SUBMISSION OF ITINERARIES.

The new ,large dog enclosures are elevated, outdoor housing with runs and a shelter box. There is no way to inspect the shelter boxes without crawling through the dog run and opening the doggie door. There is no access to properly inspect the inside of the shelter boxes.

Each breeder shall allow APHIS officials to inspect and photograph facilities, property and animals.

An appropriate means to inspect the shelter boxes must be constructed to allow inspection of all facilities.

OUTDOOR HOUSING FACILITIES.

The new large kennel shelter boxes are made of wood that has not been sealed.

Building surfaces in contact with animals in outdoor housing facilities must be impervious to moisture.

Seal the wood shelter boxes so that they can be properly cleaned and sanitized to prevent odor and disease hazards.

3.11(a)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The feces and food waste below the large dogs runs has not been removed since the dogs arrived in January, 2016. There is a strong smell of feces and an excessive amount of insects.

Excreta and food waste must be removed as often as necessary to reduce disease hazards, insects, pests and odors.

Remove the feces and food waste from under the dog runs as often as necessary to prevent odor and insect
