The degus that are group housed have excessive feces in there enclosures. The guinea pig has excessive urine and feces in its enclosure and the rabbits have excessive feces in there enclosures, or litter box.

Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors.

Remove urine and feces as often as necessary to prevent contamination of the animal enclosed, minimize disease hazard and to reduce odor.
