Time and method of identification.

Dog #119 and dog #115 were missing their tags during inspection. Dog #119's tag was found in the enclosure with a broken chain-type collar. The representative said dog #115's tag was noticed lost about a week ago and hasn't been found. Proper official identification is required and needs to be worn on each dog with a safe collar. Proper identification is important to help with husbandry tracking of animals. Ensure to maintain each dog's official identification attached with a safe collar as required.

3.1(c)(1)(ii) Repeat

Housing facilities, general.

The enclosure for a female golden retriever closest to the east door has a row of chain link with points that she could touch. Wire points can cause injury. Ensure that enclosures/pens are maintained so that there are no sharp points that animals could contact.

Note: Item was corrected at time of exit interview.

3.11(c)

Cleaning, sanitization, housekeeping, and pest control.

The exercise area which the representative said is used to let dogs run in while cleaning their pens has some overgrown areas of weeds that include burdock and thistle. Overgrown weeds can make it difficult to keep the exercise area clean. Burdock and thistle can get in dogs' hair and cause matting/discomfort. Ensure to maintain plants in the exercise area in a manner that helps promote the health and wellbeing of the dogs that use it.

Note: Burdock and thistle were removed from exercise area prior to exit interview.

This is a 1st Re-License Inspection for a Class A license. The inspection and exit briefing were conducted with the applicant.
