**Time and method of identification.**  
12 French Bulldogs in the kennel that are older than 16 weeks of age do not have official identification affixed. Official identification (such as a tag) is required for all dogs 16 weeks or older in the kennel. Lack of proper identification can make tracking health information and husbandry tasks difficult. Ensure all dogs are properly identified as required. Correct by 7/2/2021.

**Records: Dealers and exhibitors.**  
Some breeding dogs weren't recorded on APHIS 7005 Record of Acquisition and Dog and Cats on Hand: 4 French Bulldogs delivered to the kennel from New York on 12-13-2020 and 8 French Bull Dogs delivered to the kennel from New York on 11-04-2020. All adult dogs on hand must be recorded on APHIS 7005. Accurate and complete records are required in case animal tracking needs to be done (for example health tracking). Ensure the record of dogs on hand (APHIS 7005) is kept up to date and accurate at all times. Correct by 6/30/2021

An adult dog was out during inspection and under the enclosure decking inside the kennel. The licensee said she jumped out an open enclosure door. The area under the enclosure decking is narrow and difficult for an average adult-sized person to access. The licensee said help from someone that fits under the area will be needed to be able to catch it. Ensure that enclosures safely contain all dogs and this area under the decking is corrected so if a dog briefly gets out it can be caught easily and safely without having it get under it where it can't easily be caught.

Correct by 7/6/2021.

Note: The dog had been caught and returned to its primary enclosure prior to the exit interview.

#### 3.11(c)

##### **Cleaning, sanitization, housekeeping, and pest control.**

The area outside the kennel is in need of some clean-up and housekeeping: A buildup of wet shavings and soiled material on the outside areas in front of the runs is creating an area for flies to live and breed in. There are weeds by the door that are growing tall and on the southwest corner outside there is a large pile of old shavings. Buildup of old shavings and overgrown weeds creates areas for flies and pests to breed in. Ensure the area around the building is kept clean and in good repair to eliminate areas that pests can live and breed in.
