**2.40(b)(3) Direct**

**Attending veterinarian and adequate veterinary care (dealers and exhibitors).**

Dogs were identified with tooth problems that have not been communicated to the attending veterinarian (AV) for treatment:  
-Male yorkie #35 had teeth that were covered in plaque and tartar, recessed gums and his lower right canine tooth was loose to gentle touch.  
-Yorkie #58 female had had teeth that were covered in plaque and tartar and recessed gums.  
-Male Maltese #50 had teeth that were covered in plaque and tartar.  
-Female yorkie #59 had teeth that were covered in plaque and tartar and had recessed gums. One of her canine teeth was slightly loose when touched.

These are signs of dental disease and can cause discomfort and health problems for affected dogs. Ensure that health problems, including dental problems are promptly communicated to the AV so that the AV can begin a treatment plan.

Male Maltese #50 was seen to occasionally shake his head. His ears had a dark buildup in them and skin was lightly reddened. The licensee said the ears were cleaned out a few days before the inspection, however had not communicated this condition to the AV for treatment guidance. Ear problems such as this can cause discomfort and in some cases spread to other dogs. Ensure to contact the attending veterinarian for ear problems so that a treatment plan can be initiated.

**3.1(c)(3)**

**Housing facilities, general.**

The outdoor runs of each run had not had adequate daily spot cleaning of excreta. The licensee said that a daily spot clean has not been in the routine. To protect dog health and comfort, surfaces dogs touch, including solid surface of outdoor runs require a daily spot clean to maintain the areas clean. Ensure to maintain a routine of daily spot cleaning for surfaces that dogs can contact.

#65 male Shih-tzu, #58 yorkie female, #50 maltese male, and #59 yorkie female. Matted hair can cause discomfort and skin problems. Ensure that dogs' coats are maintained free from matted hair.
