Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The facility had one puppy death in a litter yesterday and another puppy was observed by the facility to not be interested in suckling but has been taking some milk replacer. The licensee was concerned this puppy's problems might be the same as the one that died but the attending veterinarian had not been contacted. The puppy was observed to have moist gums but when compared with littermates' interest in suckling the dam, it was seen to be uninterested. Lack of communication with the attending veterinarian on the health of this puppy might cause it to be in discomfort or have its condition worsen. If an animal is unwell and the program of veterinary care does not instruct care for a condition, the facility must contact the attending veterinarian to have the animals evaluated and follow the attending veterinarian's treatment plan.

NOTE: The inspection was paused and the licensee contacted the attending veterinarian who plans to visit and observe the litter today.

The facility has pyrantel stored and that has been used that expired 5/2021. Expired medications might not work to prevent/treat conditions or might make animals sick. Ensure that expired medications are not used for animals in the
