2.50(a)(1)

Time and method of identification.

None of the adult dogs in the kennel are properly identified by a tag, tattoo, or microchip. Improper identification on all adult dogs doesn't ensure the dogs can be easily identified and traced by an APHIS official. All adult dogs must be identified by tag, tattoo, or microchip. Correct by 8/26/23.

3.1(a) **Critical** **Repeat**

Housing facilities, general.

A black and white female rat terrier (#1009) escaped from the licensee's premises on 4/12/23. The licensee was unable to find the dog. A dog that is able to escape from the licensee's premises could get injured by a car, could become prey to a wild animal, may not be able to find proper food, water, or shelter, and could end up deceased. The licensee must properly contain all regulated dogs so the dogs are unable to escape from the licensee's premises.

3.1(f)

Housing facilities, general.

The top row of the outdoor kennels doesn't have a proper drainage system set up. Plastic sheeting is set up to direct the urine and fecal material towards the building and from there the licensee can spray the waste material towards one end. There is a gap between where the building meets the plastic sheeting allowing the waste material to drain into the enclosures below. By allowing the waste material to drain into the enclosures below, the dogs below are potentially being exposed to various diseases and parasites. The drainage system for the upper row of enclosures needs to be fixed so it doesn't allow waste material to drain into the enclosures below. Correct by 8/2/23.

3.11(c) **Repeat**

Cleaning, sanitization, housekeeping, and pest control.

The licensee has a pellet stove in his kennel. Behind the pellet stove on the floor is a black waste material (licensee referred to as creosote) that is building up. In addition, small bugs were observed to be crawling around on a penicillin bottle which was next to the vaccines in the cold storage container. Waste material from the pellet stove may be hazardous to the dogs and anyone working in the kennel. Bugs crawling around in cold storage could contaminate any vaccines or medications being stored in there. Waste material on the floor in the kennel needs to be cleaned up on a

regular basis to prevent build-up. The cold storage needs to be cleaned out on a regular basis to remove any bugs that are present. In addition, the licensee should look at ways of preventing bugs from entering the cold storage.

3.13(a)(4)

Veterinary care for dogs.

One adult and two puppies had feces caked in their fur around the anus. Caked up feces could block the anus and the dog could have trouble defecating if it were to get any worse. In addition caked up feces can cause irritation and infection of the skin. The licensee must groom the dogs on a regular basis to prevent feces from building up around the anus. Correct by 7/28/23.
