The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries;

A guinea pig was observed to limp on it's right hind leg. Most of the time observed, it would not bear weight on the right hind leg. Workers report it was separated a couple days ago into it's own cage and had a note on the cage, however the Attending Veterinarian has not been notified about the problem and the guinea pig is not receiving any treatment. Limping and not bearing any weight on a leg can be a sign of a painful condition and must be addressed promptly by a veterinarian so that the animal receives appropriate treatment and pain relief if necessary. Health problems or signs of injury in animals must be communicated to the Attending Veterinarian in a timely manner.
