2.40(b)(2) REPEAT

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

A female Pomeranian microchip #005-008-600 continues to have problems with her teeth and right ear. The upper teeth remain covered in a dark hard material and the dog's right ear has redeveloped a thick brown discharge that is matted in the hair. Tooth problems can be painful and cause further health issues in dogs if not treated. The discharge from the ear may be a sign of a problem in the ear and needs to be evaluated if it needs proper treatment. To ensure that this dog is not in pain and receives appropriate treatment have the attending veterinarian evaluate it to diagnose the ear and teeth problems and treat them per the veterinarian's instructions. Documentation of the dog's diagnosis must be kept for future inspections.

2.50(a)(2) REPEAT

TIME AND METHOD OF IDENTIFICATION.

One puppy was not identified by an official USDA identification method (cage card, tag, or plastic collar). Lack of official identification does not allow for the proper identification or tracking of the animals. Correct by identifying all puppies with an official USDA method of identification.

2.75(a)(1) REPEAT

RECORDS: DEALERS AND EXHIBITORS.

The acquisition of four adult dogs has not been recorded on the APHIS 7005 inventory forms. One puppy birth has not been recorded on an APHIS Form 7005 or on a cage card. Lack of accurate and up-to-date inventory records does not ensure for the proper tracking of the animals by APHIS Officials as necessary. Update the facility inventory records with all required information so they accurately reflect the current inventory of animals.
