TIME AND METHOD OF IDENTIFICATION.

None of the adult dogs in the kennel are identified with official USDA identification. The licensee intends to use tags, but to date has not affixed the tags to any of the dogs. Lack of official identification does not ensure for the proper identifying and tracking of the animals. All adult dogs must be identified by official USDA identification. Correct by August 18, 2015.

RECORDS: DEALERS AND EXHIBITORS.

Facility inventory records (APHIS Form 7005) are not current and up-to-date. There are five new acquisitions of Sheba Inu and American Eskimo puppies that are not recorded and three German Shepherd dispositions that have not been recorded. Lack of current, accurate and up-to-date inventory records cannot ensure for the proper documentation and tracking of the animals. Record all acquisitions and dispositions on the facility inventory records in a timely manner. Correct by August 18, 2015.

ACCESS AND INSPECTION OF RECORDS AND PROPERTY; SUBMISSION OF ITINERARIES.

Disposition records (APHIS Forms 7006) were not able to be reviewed at the time of this inspection because the licensee was unavailable and the facility representative did not have access to all of the facility records. Not being able to review the disposition records does not ensure that proper documentation and record keeping requirements are being met. Ensure that all required facility records are available for review by APHIS officials at the time of inspection. Correct from this day forward.

3.1(e)

HOUSING FACILITIES, GENERAL.

There is an open bag of puppy food sitting on the floor that is not stored in a container with a lid. Improper storage of food does not adequately protect the food from contamination. Store all open supplies of food in containers with lids. Correct by August 18, 2015.

3.3(e)(1)

SHELTERED HOUSING FACILITIES.

The licensee has recently laid new cement floors in the inside and outside portions of the dog enclosures, but the cement floors are not currently impervious to moisture. Surfaces that are not impervious to moisture cannot be properly cleaned and sanitized. All cement surfaces in contact with the dogs must be made impervious to moisture. Correct by September 11, 2015.

3.11(a)

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

The outside portions of the middle enclosures have more than one days worth of feces present within them. There is also an accumulation of soil and other debris present in the inside portions of the middle enclosures. Also the enclosure currently housing an unidentified pregnant female Chihuahua has an accumulation of feces, soiled bedding and food waste present in her primary enclosure area and within the collection tray beneath. Excessive accumulations of feces, food waste, soiled bedding and other debris cannot prevent the soiling of the dogs housed within, is a potential disease hazard, can attract pests and create odors. Excessive feces, waste and other soiled materials must be cleaned daily from the enclosures daily and as often as necessary to prevent accumulation of such materials. Correct by August 14, 2015.
