Time and method of identification.

* There are an estimated 25 dogs that have no official identification on them at time of inspection. Official identification is needed to ensure that each animal's identity can be known with certainty which helps to facilitate the inspection process. The applicant must ensure that all live dogs on the premise shall be identified by an official tag, or a distinctive and legible tattoo marking that is acceptable to and approved by the Administrator. If the licensee uses microchips as official identification, then a functioning microchip reader must be made available to the inspector at time of facility inspection. In addition, a variance from the regional office to use microchips must be maintained on file by the licensee.

3.6(a)(2)(x)

Primary enclosures.

* Ten un-weaned puppies are being housed on square plastic flooring that will allow the feet and legs to fall through the openings in the flooring. The feet and legs of two puppies were observed falling through the openings of the enclosure flooring. The licensee had covered a portion of their enclosures with carpet squares. However, there is nothing to prevent these young puppies from moving to the uncovered portion of the enclosure where their feet and legs can fall through the openings in the flooring. The daily activity and mobility of the puppies are affected when their feet and legs fall through the openings. The potential for injury exists when the feet and legs pass through the openings in the flooring. All primary enclosures must have floors constructed in a manner that protects the puppy's feet and legs from

injury and does not allow the puppies' feet or legs to pass through any openings. Primary enclosures must have floors that are constructed in a manner that protects the puppy's feet and legs from injury and do not allow the puppies feet and legs to pass through any openings. The licensee must have floors that are constructed in a manner that protects the puppy's feet and legs from injury.

Veterinary care for dogs.

* No recorded date for annual heartworm testing for 125 dogs had been completed. Annual heartworm testing is important for the health of the animals. Heartworm testing is done to ensure that there are no active internal parasites. The applicant must ensure that all dogs are receiving vaccinations for contagious and/or deadly diseases of dogs (including rabies, parvovirus, and distemper) and sampling and treatment of parasites and other pests (including fleas, worms, coccidia, giardia, and heartworm) in accordance with a schedule approved by the attending veterinarian.

This is a 1st Re-License Inspection for a Class A license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspection(s) or by April 16, 2023 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
