ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Female Maltese (ID#780) has a buildup of a dark brown/grey material on the surface of the upper and lower canine teeth, the upper front teeth and the remaining side teeth.

Female Maltese (ID#654) has a buildup of dark brown/grey material on the surface of the upper canine teeth, the upper front teeth and the remaining side teeth. Beneath the right eye is a moderately reddened area that has a small pink lump protruding from it.

Poor dental health can cause pain and discomfort to the dog as well as lead to further health complications. The above mentioned dogs must be evaluated by a licensed veterinarian for proper diagnosis and treatment plan. The diagnosis and treatment plan must be documented and available to the inspector upon request. The licensee must ensure that all dogs receive adequate veterinary care at all times.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

In the Yorkshire terrier building nearly all the access doors in the dog enclosures has an excessive buildup of dark brown dirt and grime on their surfaces. There are at least sixty dogs housed in the affected enclosures. The buildup of dirt and grime can increase the disease risk towards the dogs.

Used primary enclosures must be sanitized once every two weeks, or as often as necessary, to prevent the accumulation of dirt, grime, food waste, and other disease hazards. The licensee must remove the dirt and grime buildup from the access doors in order to eliminate the disease risk. The licensee must ensure that all used primary enclosures remain free of dirt and grime buildup at all times.
