ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

In the "small dog building" red male Dachshund "Sam", microchip # 497-115-1616, had a brownish gray buildup on the left and right sides of the mouth along the upper cheek teeth. There is an area about 2 by 3 inches in size above and to the back of his right eye of thinning and patchy hair with small black to brown colored scabs. The licensee said that she did not know what it was from, but assumed he had an injury that has now healed. The health of the teeth can impact chewing and digestion, and overall health of the animal.

In the area storing vaccinations and medicines ready to use there is a bottle of Pyrantel Pamoate Suspension with an expiration date of May 2014 a bottle of Safe-guard dewormer with an expiration date of May 2014, and approximately eight vials of Duramune Max 5 vaccinations with expirations dates of July 5, 2015. The licensee stated she vaccinated the nine puppies at the beginning of August 2015 with the expired vaccinations. Expired medications can have unknown results and effectiveness on the animals.

The licensee must use appropriate methods to prevent, control, diagnose, and treat diseases and injuries.

RECORDS: DEALERS AND EXHIBITORS.

The Dogs on Hand Form(s) (APHIS Form 7005) is incomplete. Thirty five regulated adult dogs were counted on site. The number of dogs on the form(s) provided is thirty three; making a difference of two dogs. Nineteen entries did not have identification numbers recorded.

The licensee has no official record(s) of the required information for puppies born on the premise.

The complete and accurate records of dogs allows for monitoring of movement of animals and disease, and the legal means of acquiring animals. The licensee must make, keep, and maintain records or forms of all regulated animals on the premise, which shall include any offspring born of any animal while in his or her possession.

PRIMARY ENCLOSURES.

The weaned puppies kept in the house are in enclosures with 7.5 square feet each. The top enclosure housing four female Dachshund puppies were on average 13.5 inches in length, requiring a total minimum of 10.56 square feet. The bottom enclosure housing two female and three male Dachshunds that were 13.25, 14, 15.5, 15.25, and 13.25 inches in length, requiring a total minimum of 14.27 square feet.

The animals need adequate space to make normal postural adjustments and for their growth and development. The licensee must provide adequate floor space equal to the length of the dog from the tip of nose to the base of the tail plus 6 inches, squared, for each animal in the enclosure if housed in groups.
