### 3.1(c)(3)

#### HOUSING FACILITIES, GENERAL.

\* Five enclosures, all housing 10 adult dogs, had an accumulation of fecal waste on the plastic flooring for the outdoor portion of the enclosures. This indicates that daily spot-cleaning is not taking place. Without daily spot-cleaning the disease hazards for the animals can increase.

For the prevention of an accumulation of excrement and reduction of disease hazards, all enclosures must be spot-cleaned daily and sanitized as necessary.

### 3.11(a)

#### CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

\* There was an accumulation of fecal waste underneath the outside portion of the enclosures, all housing 15 adult dogs, for the main shelter kennel. When asked, the owner stated, that area was cleaned in the fall in spring. This accumulation of waste can increase disease hazards, cause odors and attract pests and vermin.

For the reduction of disease hazards, odors, insects and pests and the prevention of an accumulation of fecal and fluid waste, the underneath area of the enclosures must be cleaned more frequently.

### 3.11(c)

#### CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

\* Feed and bedding storage room had pieces of foam insulation of the ground, on top of carpet bedding and canned dog food. There were large rolls of carpet ready for use as bedding lying on the ground. There was empty plastic bags on the floor around the food and carpet bedding. An moderate odor of cat urine was present. This can attract and provide living and breeding areas for rodents and other pests and vermin affecting the health and well-being of 57 adult dogs and two puppies.
