OUTDOOR HOUSING FACILITIES.

Adequate bedding

In one of the igloo style shelters there is not enough bedding provided. There is some bedding provided but bare floor was visible. When questioned as to when the last time he had provided bedding for this shelter the licensee replied "last weekend". The temperature for the area, according to www.noaa.gov, was measured at 32 degree F for the high and 21 degrees F for the low. When temperatures fall below 35 degrees F additional bedding must be provided for the dogs so that they can burrow down into the material to stay warm. The licensee must provide additional bedding to this outdoor shelter and ensure that when the temperatures fall below 50 degrees F bedding must be provided to all outdoor enclosures and when the temperature falls below 35 degrees F additional bedding must be provided so that the dogs can stay warm.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

Food and water receptacles

Inside two enclosures, affecting 4 dogs, the self feeders had a thick layer of straw bedding packed into the food trough area completely covering the feed. This amount of straw bedding made it difficult for the dogs to retrieve the food from the receptacles which could lead to potential health related issues. Inside two enclosures, affecting 3 dogs, the water receptacles had a thick layer, approximately 1 inch, of sawdust and/or hair on the bottom of the water receptacle under the waters level. This could lead to potential health related issues. The licensee must clean these food and water receptacles and ensure that all food and water receptacles are kept clean to prevent an accumulation of dirt, debris, food waste, excreta, and other disease hazards.
