ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Male Chihuahua (microchip #483A256902) has overgrown toenails. The toenails have become excessively long and have developed a severe curve.

Female Chihuahua (microchip #0006FACC44) has overgrown toenails. The toenails have become excessively long and have developed a severe curve. The nails of the dewclaws on both front legs have grown completely around and are nearly touching the back of the digit.

Overgrown toenails could cause pain and discomfort to the dogs, as well as, affect the dog's natural gait. The licensee must have the toenails on the above mentioned dogs trimmed to an acceptable length. The licensee must ensure that the toenails of every dog are kept at an acceptable length at all times in order to promote their health and well-being.

2.40(b)(3) CRITICAL

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

In the outdoor section of one enclosure is a deceased female Chihuahua (microchip #0007296B3B). The dog is located at the end of the enclosure lying on her right side up against the enclosure gate. There is a large, circular open wound in the lower left side of the abdomen directly in front of the left hind leg. The licensee said this dog tended to have intermittent issues with uterine infections during the time she has been at the facility.

The licensee stated that he normally conducts daily observations of the dogs in the evening, therefore had not observed the dogs at the time of the inspection, but the licensee had observed the dog during the weekend and it had been fine at that time. The day before the inspection, the licensee stated he had been inside the kennel three times, but did not walk around the outside of the kennel at anytime and couldn't be sure this dog had been observed on that day.
