2.50(a)(1) Repeat

Time and method of identification.

Male Yorkshire terrier "Tucker" is over 16 weeks of age and does not have an official form of identification. Identification is necessary in order for USDA officials to identify dogs during inspection.

All live dogs held on the premises shall be identified by an official tag affixed to the animal's neck by means of a collar made of material generally considered acceptable to pet owners as a means of identifying their pet dogs, or shall be identified by a distinctive and legible tattoo marking acceptable to and approved by the Administrator. The licensee must provide "Tucker" with an official form of identification and must ensure that all dogs over 16 weeks of age have an official form of identification at all times.

2.75(a)(1) Repeat

Records: Dealers and exhibitors.

Three enclosures, with a total of four puppies less than 16 weeks old, had no cage cards or other means of identification. All dogs need to have some form of identification for tracking in case of disease outbreak or regulatory investigation. All enclosures containing puppies less than 16 weeks of age must have properly completed cage cards. The licensee must ensure that all puppies under 16 weeks of age have cage cards or other approved methods of identification at all times.

Records: Dealers and exhibitors.

There are numerous dogs, including "Louie" and "Lovie", that are listed on the facilities APHIS Form 7005 (Acquisition of Dogs and Cats on Hand), but are no longer at the facility and there is no date or method of disposition recorded. The date and method of disposition are necessary to determine an accurate count of the number of dogs at the facility and trace the movement of dogs.

Each dealer shall make, keep, and maintain records or forms which fully and correctly disclose the required information concerning each dog including the date and method of disposition. The licensee must update APHIS Form 7005 to include the date and method of disposition for each applicable dog. The licensee must ensure that APHIS Form 7005 is kept up-to-date at all times.

Repeat

Housing facilities, general.

In one enclosure, containing one adult dog and one puppy, there is a large amount of clutter stored on top of the enclosure. The clutter consists of a clock, stacks of paperwork, plastic containers, and bottles of veterinary care products. Another enclosure, containing two adult dogs, has a large plastic container placed on top of the enclosure. Clutter stored on top of the enclosures could impact the movement of air, as well as become too heavy and cause the top of the enclosure to collapse potentially injuring an animal.

Animal areas inside of housing facilities must be kept neat and free of clutter. The licensee must remove the clutter from the tops of the enclosures and ensure that all housing areas remain free from clutter at all times.

3.6(c)(1)(i)

Primary enclosures.

One enclosure, containing one adult dog ("Bridgette", #86) and one puppy, does not provide the minimum amount of floor space. The adult dog measured 15 inches in length requiring a minimum floor space of 3.06 square feet. The puppy measured 12 inches in length requiring a minimum floor space of 2.25 square feet. Together, the puppy and adult require a minimum floor space of 5.31 square feet and the enclosure they are housed in has a floor space of 3.95 square feet.

One enclosure, containing one adult dog ("Tucker") and one puppy, does not provide the minimum amount of floor space. The adult dog measured 15 inches in length requiring a minimum floor space of 3.06 square feet. The puppy measured 14 inches in length requiring a minimum floor space of 2.78 square feet. Together, the puppy and adult require a minimum floor space of 5.84 square feet and the enclosure they are housed in has a floor space of 4.43 square feet.

Failure to provide the minimum amount of space in which to house the dogs could have a negative impact on their health and well-being.

Each dog housed in a primary enclosure (including weaned puppies) must be provided a minimum amount of floor space as required by the Animal Welfare Act. The licensee must house the above mentioned dogs in an enclosure that provides the minimum amount of floor space. The licensee must ensure that all dogs are provided with the minimum amount of floor space at all times.

A complete exercise plan that has been approved by the attending veterinarian is important to ensure the dogs are receiving adequate space and exercise to support their health and well-being.

The licensee must have an appropriate plan, approved by the attending veterinarian, that provides all dogs with the opportunity to exercise.

Watering

Three enclosures, housing 5 dogs, have empty water receptacles. The program of veterinary care provided by the attending veterinarian in November 2020, advises the licensee of the new watering rule and the requirement for a continuously available potable water.

Continuous access to potable water is important for the health and well-being of the dogs and it is a specific requirement of the Animal Welfare Act.

Potable water must be continuously available to all dogs. The licensee must ensure that all dogs have access to potable water at all times.
