The facility needs to transfer all records of animals on hand to APHIS Form 7005.

Housing facilities, general.

The facility has two pallets of bedding material stored in a barn that also is used to stored hay and other materials. There is small pile of loose hay built up around one side of one pallet.

Piles of loose hay can shelter mice and other vermin that may then infest the bedding. Supplies of bedding material must be stored in a manner that protects them from contamination and vermin infestation.

The area around the pallets of bedding must be cleaned and cleared of all hay and other debris.

Inspection Report

Three feeders for approximately 7 dogs have an excessive build up of brown colored organic material in openings where the dogs eat that is in direct contact with their food. The owner says he cleans the feeders once a month.

Dirty feeders lead to a build up materials that can shelter bacteria, contaminate food, and cause illness. Animal Welfare Act (AWA) regulations states self-feeders must be kept clean and sanitized at least once every two weeks.

Dirty feeders must be cleaned or replaced and all feeders sanitized using a method and frequency that meets the requirements of the AWA.

This inspection was an announced site approval inspection. This site is not ready for approval to conduct activity covered under your current Animal Welfare Act License.

Conducting regulated activities at a non-approved site is a violation of the Animal Welfare Act. Please contact your inspector to schedule your next new site approval inspection.
