3.4(b)(3)

Outdoor housing facilities.

Two adult Mastiffs are housed in an outdoor enclosure which contains a wooden shelter structure. The shelter has no wind and rain break at the entrance. Failure to provide a wind and rain break at the shelter door does not ensure the dogs are fully protected from severe weather conditions which could have a negative impact on their health and well-being.

Shelters in outdoor housing facilities must be provided with a wind and rain break at the entrance. The licensee must add a wind and rain break to the entrance of the shelter to ensure the dogs are fully protected from weather extremes at all times.

3.4(b)(4)

Outdoor housing facilities.

Two adult Mastiffs are housed in an outdoor enclosure which contains a wooden shelter structure. The interior of the shelter contains no bedding material. The high temperature on the day of the inspection was 25 degrees F according to The Weather Channel. Failure to provide bedding material does not ensure the dogs are properly protected against frigid

temperatures which could have a negative impact on their health and well-being.

Shelters in outdoor housing facilities must contain clean, dry bedding material if the ambient temperature is below 50 degrees F and additional clean, dry bedding material is required when the temperature is 35 degrees F or lower. The licensee must add an adequate amount of clean, dry bedding material to the interior of the shelter in order to protect the dogs from extreme cold weather.

To be corrected by: The licensee added bedding material to the shelter at the time of the inspection.

3.4(c)

Outdoor housing facilities.

Two adult Mastiffs are housed in an outdoor enclosure which contains a wooden shelter structure. The interior and exterior surface of the wooden shelter are not impervious to moisture. Wood that is not impervious to moisture may rot which could affect the shelter's structural integrity. Additionally, wood not impervious to moisture cannot be properly cleaned and sanitized which could increase the risk of disease hazards towards the dogs.

Building surfaces in contact with animals in outdoor housing facilities must be impervious to moisture. The licensee must alter the wooden shelter in a manner that makes the interior and exterior surfaces impervious to moisture in order to ensure the structure remains safe and sanitary at all times.

Two enclosures, containing a total of 10 adult dogs and 2 puppies, have receptacles containing dog food that is heavily contaminated with wood shavings. The shavings are mixed into the food or have formed a layer across the top of the food. The large amount of shavings inside the receptacles makes it impossible for the dogs to consume the food without also ingesting shavings.

Dogs must be provided with food that is uncontaminated, wholesome, palatable, and of sufficient quantity and nutritive value to maintain the normal condition and weight of the animal. The licensee must remove the wood shavings from the food receptacles and ensure that all food sources remain uncontaminated at all times.

To be corrected by: At the time of the inspection, the licensee removed the contaminated food and shavings from one receptacle and was verbally instructed to remove the shavings from the other receptacle by the end of business 26-January-2022.

3.10(a)

Watering

Three enclosure, housing an approximate total of 2 adult dogs and 13 puppies, have no water in the water receptacles. The receptacles were completely dry and some had been flipped upside down. One outdoor enclosure, housing 2 adult Mastiffs, has water in the water receptacle but it has frozen into a solid block of ice. The Mastiffs have no additional source of potable water. Failure to continuously provide potable water could allow the dogs to become dehydrated which could have a negative impact on their health and well-being.

Potable water must be continuously available to the dogs. The licensee must ensure that potable water is available to the dogs at all times including during times of extreme cold.
